1. Introduction

This specification provides the definition of the Direct debit message (DIRDEB) to be used in Electronic Data Interchange (EDI) between trading partners involved in administration, commerce and transport.

1.1. Scope

1.1.1. Functional Definition

Prior to the Direct Debit procedure, some agreement(s) would usually have been concluded :

- agreement between the Creditor and his Bank (mainly to specify the conditions of credit and the kind of direct debit).
- agreement between the Debtor and the Debtor's Bank (i.e. pre-authorization and condition of debit), or between the Creditor and the Debtor.

A Direct Debit is sent by the Creditor to the Creditor's Bank instructing it to claim specified amount(s) from the Debtor(s) and to credit the amount(s) to an account specified in the message, which the Creditor's Bank services for the Creditor in settlement of the referenced transaction(s).

Throughout this document the term 'Creditor' refers to either a Beneficiary or a Payee, likewise the term 'Debtor' refers to either an Ordering Customer or a Payor.

The term 'Bank' may be interpreted as any financial institution.

The term 'pre-authorization' refers to an agreement between a Creditor and a Debtor for

- either automatic debiting, as required,
- or for debiting unless rejected by the debtor in a period of time.

The agreement can also be made between the debtor and his bank, independently of the amount of the DIRDEB.

1.1.2. Field of Application

This message type may be applied, for both national and international settlements, but it is based on the national existing rules of the debit side.

1.1.3. Principles

- A Direct Debit may cover the financial settlement(s) of one or more commercial trade transactions, such as invoices, credit notes, debit notes, etc. It is not intended for use in securities trading.
- Several credit accounts, execution dates and currencies may be specified.
- Charges may be borne on account(s) different of the account(s) held by the Creditor.
- The Creditor's Bank may need a confirmation/authorization (AUTHOR) from the creditor to be able to process the Direct Debit Message.
- Pre-authorized and non pre-authorized direct debits shall not be mixed within the same message.
- The only way to modify a Direct Debit message is to cancel the whole message or a transaction thereof (e.g. by the use of the FINCAN message). In that respect, one to many order(s) could be cancelled within the message, avoiding to be obliged to cancel the whole message.

The cancellation of a message can only be effected by the originator of the message. The kind of cancellation is dependent upon the process of the message or a transaction of it.

1.3. Data Segment Clarification

The following semantic principles applying to the message are intended to facilitate the understanding of the message:

The Direct Debit message is structured in three levels: A, B and C.

- Level A contains general data related to the whole message and is contained in Segment Groups 1, 2, 3 and 24 and the Heading/Trailing sections.
- Level B contains data from the credit side (one credit account, one currency, one execution day) and data which applies to all the dependent C levels and is contained in Segment Group 4 through Segment Group 10.
- Level C contains mainly data related to the debit side and, may contain remittance information. This data is considered as unique for each debit transaction and is contained in Segment Group 11 through Segment Group 23.

The structure of the message is designed to allow several B levels, each B level being followed by its related C levels.

3. Segment Layout

3.1. Introduction

This section describes each segment of the UN/EDIFACT message DIRDEB.

Each segment is presented in a separate table and in the sequence in which they appear in the message.

The upper half of each table provides information about the segment or segment group concerned, the lower part of the table describes the data elements (composite and simple).

Each table is structured in three vertical blocks: UN/EDIFACT Directory 96.A, D6 and an empty block:

3.1.1. UN/EDIFACT Directory 96.A Block

The left third of the table provides information extracted from the original UN/EDIFACT Directory 96.A.

In the first line of this block, the segment or segment group tag is followed by the maximum number of occurrences.

The second line contains the (M)andatory / (C)onditional indicator at segment level, according to the UN/EDIFACT Directory 96.A

In the lower half of the table, the data element tag (composite or simple) and full name are followed by the corresponding (M)andatory / (C)onditional indicators and the format.

3.1.2. D6 Description Block

This block presents the recommendations of D6 (EWG sub-working group Finance).

Both for segment level and for date element level (simple and composite), the following status/sub-status are defined:

M	MANDATORY	The entity is mandatory and must be sent (according to directory, unchanged)
R	REQUIRED	The entity is required and must be sent
D	DEPENDENT	The entity must be sent in certain conditions, as defined by the relevant explanatory note

O	OPTIONAL	The entity is optional and may be sent at the discretion of the user
N	NOT USED	The entity is not used and should be omitted. Any data placed in an element marked with N will be ignored.

At data element level:

- The first column indicates the status as defined above (with the options M, R, D, O, N);
- The second column includes information affecting the code values as follows:

*	Restricted codelist	Code values preceded by an asterisk (*) are the only codes available for use in the given context
<blank>	Open codelist	Code values not preceded by an asterisk (*) are not restricted (they are open). The available codes are listed in the codelist of the corresponding UN/EDIFACT directory.
* R	Required code in a restricted list	Codes preceded by an “R” are required and must occur in one repetition of the corresponding segment if used.
R	Required code in an open list	Codes preceded by an “R” are required and must occur in one repetition of the corresponding segment if used.

- The third column provides additional comments and descriptions.

Note that if a segment group/segment/composite data element is flagged as “N”, all data elements within that segment group/segment/composite data element will have blank status indicators.

3.1.3. Third Block

The last block of the table describes the preferred use of the message for a group of multinational companies constituting the “Corporate Reference Group” (CRG). The CRG is established as a forum for discussion of standardisation issues. The members of the group are predominantly companies with activities in several countries and a large resource base.
