Foreword

This document describes the use of various codes in various code lists occurring in EDIFACT message types of the finance domain.

This document is NEITHER a replacement for any official code list published by the UN/CEFACT, NOR it intends to overrule those publications. It just choose and extracts codes from the named lists and attach it to a meaningful context of the financial domain. This implies a restriction to those codes to the given contexts.

Temporary codes may be used to cover urgent needs of trading partners. If ever temporary codes occur in this document they are replaced as soon as available with official assigned codes.

This separate documentation should

- ease editorial tasks
- modularise the documentation
- enable and support the overall integrity of the messages.

Both partners of a data exchange, e.g. sender and receiver in their respective role, always need an agreement to send data to each other. This agreement may contain additional rules and even regulations that overrule any of the subsequent described recommendations.
